

## **Notice regarding submissions**

By submitting a video, photo, or any other visual content for publication on the American Orthopaedic Society for Sports Medicine (“AOSSM”) website, you expressly warrant that: i) you are either the owner of the content or have secured permission from the copyright owner of the content to publicly display it; and ii) posting this content will not violate any trade secret or privacy right of any party. Additionally, you grant to AOSSM a royalty-free, perpetual, irrevocable, world-wide nonexclusive license to reproduce, publish, edit, distribute, transmit, perform, and display the content in any media, form, format, or forum now known or hereafter developed. You agree to indemnify AOSSM and its affiliates, directors, officers, employees and licensees and hold them harmless from any and all claims, damages, costs and expenses, including attorneys' fees, arising from the display of the content on the website and/or the use of the content by AOSSM and/or your failure to comply with the terms stated above. AOSSM reserves the right to review all content prior to posting to the site and to remove any content for any reason, at any time, without prior notice, at our sole discretion.

## **Permissions for video content**

Two types of permission must be obtained for video content – i) a copyright permission signed by the person who created the video or other party to whom copyright has been transferred, and ii) a visual/privacy release signed by all identifiable people with a reasonable expectation of privacy who appear in the video. When determining whether a person is identifiable, consider whether the person would be recognizable to themselves or those who know them. Even if the person's face is not viewable, keep in mind that features such as a tattoo or other unique feature or the person's voice may be enough to make them identifiable. If there is any doubt, always secure the person's permission to use their likeness. When determining reasonable expectation of privacy, consider whether the person is a private or public (famous) figure, and whether he/she was filmed in a private or public situation. For instance, a professional baseball player would not have a privacy expectation while participating in a televised game, and no visual/privacy release would be needed. If any of the subjects in the video are minors, a visual likeness/privacy release must be signed by each minor's parent or legal guardian consenting to the use of the minor's likeness on this site. Upon request, AOSSM can provide you with forms for securing copyright and visual likeness/privacy permissions.

## **Copyright and fair use**

The Fair Use doctrine allows the use of content without copyright permission in limited instances. This is not a black and white determination, but established by weighing several factors within the context of the use.
